



## TERMS AND CONDITIONS OF USE AND SALE

### 1. PURPOSE

The following Terms and Conditions of use and sale (the "General Conditions") are intended to inform you ("You" or the "User") about the conditions under which you may:

- i. access BetCity.co website and the various types of content posted thereon or related thereto (including, without limitation, opinions, information, data, files, text, images, photos, audio and video files, or any other items protected by copyright or any other intellectual property rights) (the "Content"), it being specified that the BetCity.co website publishes a sports information website specializing in results forecasting and predictions;
- ii. order a selection from a specific sports events, tournament or championship for which a tipster selected by BetCity.co will provide a combination of (i) the type of bet (simple bet, over/under, asian handicap bet or other), (ii) and the example odds available from the bookmakers (The "Tip" or "Tips").

To provide the services, BetCity.co will send You the tips You have ordered via SMS or by email at least 2 hours before the sport event starts. The tips are provided to BetCity.co by qualified Sports Analysts. The Sports Analysts have been carefully selected by Us. However, you should note and be aware that the Sports Analysts' past performance will not be a warranty of their future performance. Except as otherwise mentioned below, BetCity.co shall not be held liable for any advice, tip and any other information or Content hosted by BetCity.co which may lead You and, more generally, the Users, to place bets, losing bets or non-appropriate bets.

BetCity.co do not accepts any form of gambling, betting or wagering. Any information published by BetCity.co is for informational and entertainment purposes only.

#### 3.1. Eligibility to place an order

#### 3.2. Service offers on the Site

The User has the option to order the following on the Site:

- 30 Days tips subscription which allow You to receive tips from our tipsters. Please note that subscription will not be tacitly renewed by BetCity.co. However, before the end of your subscription, you will receive a reminder by email or SMS in order to alert you of the end of such subscription.
- All the subscriptions are unlimited in term of number of tips. BetCity.co guarantee a minimum of 60 tips per month. If for any reason, the number of tips on 1 subscription is under 60, then the subscription will be extended until it reaches 60 tips.

#### 3.3. No right of withdrawal

Except otherwise stated hereinafter, the User acknowledges and agrees that no right of withdrawal or any refund of any kind is granted to the User as part of these General Conditions.

#### 3.4. Order cancellation

BetCity.co reserves the right to refuse, without being liable for any damage or costs, an order already accepted by us in the following situations, without limitation:

- your billing information is not correct or not verifiable;
- your order is flagged up by our security systems as an unusual order or an order susceptible to fraud;



- We have reason to believe You are under 18;
- We have reason to believe that You resell or make available tips to third parties.

### 3.5. Warning

BetCity.co informs the visitors of the Site, subscribers or any other users that the tip news, information, statistics and recommendations published on the Site are provided for information purposes only. Neither BetCity.co nor the Sports Analysts guarantee the accuracy of any information on the Site. The Site's visitors and subscribers therefore confirm that they have legal capacity and acknowledge that they shall be solely liable for their acts and decisions. The Users shall not hold BetCity.co, its owner, or the Sports Analysts liable on the basis of any recommendations or information provided. You shall be solely liable for any use You make of the information and tips published. Sports betting is subject to various laws.
